

U.S. Service Academy Guidelines

The U.S. Service Academies are among the most highly respected educational programs in the nation. To be admitted to an academy, a prospective applicant must meet stringent academic, physical, and medical requirements specified by federal law. As a cadet/plebe at an academy, you will be provided a fully-funded four-year college education. By law, graduates of service academies are appointed commissioned officers in their respective service and are required to serve at least five years of active duty. For graduates of the United States Merchant Marine Academy, the obligation will be with the U.S. Navy Reserve.

It is a tremendous honor to receive a Congressional nomination and appointment to a service academy. Only the brightest of America's youth are offered a chance to attend one of these historic institutions. An appointment carries great responsibility, positioning you among our nation's military leaders who defend our freedoms around the world.

A nomination is required to gain an appointment to the Naval Academy, Air Force Academy, Military Academy at West Point, or the Merchant Marine Academy. A Congressional nomination is not required to attend the U.S. Coast Guard Academy. All applicants interested in the Coast Guard Academy must contact the academy directly by mail or online. Those interested in serving in the Marine Corps should apply to the Naval Academy.

While you must have a nomination for an appointment, a nomination does not guarantee an appointment. The academies will make the final decision on each candidate based on their own standards. An elected official may nominate you, but only an academy may appoint you.

Eligibility Requirements

Each candidate must:

- be at least 17 years old, but have not passed their 23rd birthday (25th birthday for the U.S. Merchant Marine Academy);
- be a citizen of the United States;
- be unmarried, not pregnant, and have no legal obligation to support children or dependents; and
- be a legal resident of Colorado's 3rd Congressional District.



Application Process

Each applicant must meet the eligibility requirements as well as submit a nomination file with Congressman Hurd's office <u>before 5:00 PM MST on Friday, October 10, 2025</u>.

A Nomination Application File consists of the following items:

- 1. Application to Congressman Hurd (this document)
- 2. High School and/or College Transcripts
- 3. Personal Statement
- 4. Two Letters of Recommendation
- 5. Resume

Application Items

1. High School and/or College Transcript

A transcript is a listing of all the high school and college-level courses you have taken and the grades you received in those classes. You may obtain a transcript by asking your high school guidance counselor for a copy. If you are in college, you may ask for a copy of your college transcript in the registrar's office. If you are in college, you will need to submit a high school transcript in addition to your college transcript.

2. Personal Statement

Please submit a typed personal statement, no longer than one page, indicating why you wish to attend a service academy and how your familial, religious, educational, athletic, extracurricular,



community, or employment experience has led you to make this choice. In your statement, please indicate how you would meet the unique intellectual and physical challenges of a service academy.

3. Letters of Recommendation

Please select two people to write letters of recommendation on your behalf. Your references may include teachers, coaches, neighbors, employers, clergy, and community leaders. Please do not ask immediate family members such as parents, siblings, or grandparents. Ask your references to write about how they came to know you and in what capacity. They should also define your qualities, describe an example of how you demonstrated sound character or judgment, and outline why they think you should receive a nomination to a service academy. Please also limit letters of recommendation to one page.

You may include your letters of recommendation when you submit the Application Nomination File, or you may ask your references to mail or email their letters directly to:

These letters must also arrive in the district office on or before the October 10th deadline or they will not be accepted. It is your responsibility to make sure your references send their letters on time.

4. Resume

The resume should be a brief account of the candidate's education, awards, volunteer service, and work experience. The resume should be no more than one page and should provide the board with an overview of the candidate's qualifications.

Personal Interview

In mid-October, a staff member from Congressman Hurd's district office will contact you to schedule an interview with the Academy Selection Board. This board is comprised of several community leaders who will advise Congressman Hurd on his nominations and offer their recommendations to him. These interviews will tentatively take place on *Saturday, November 8th and Saturday, November 15th*. We plan to have interviews in Grand Junction and Pueblo, but depending on our applicant pool, we may expand to other cities across Colorado's 3rd Congressional District.
